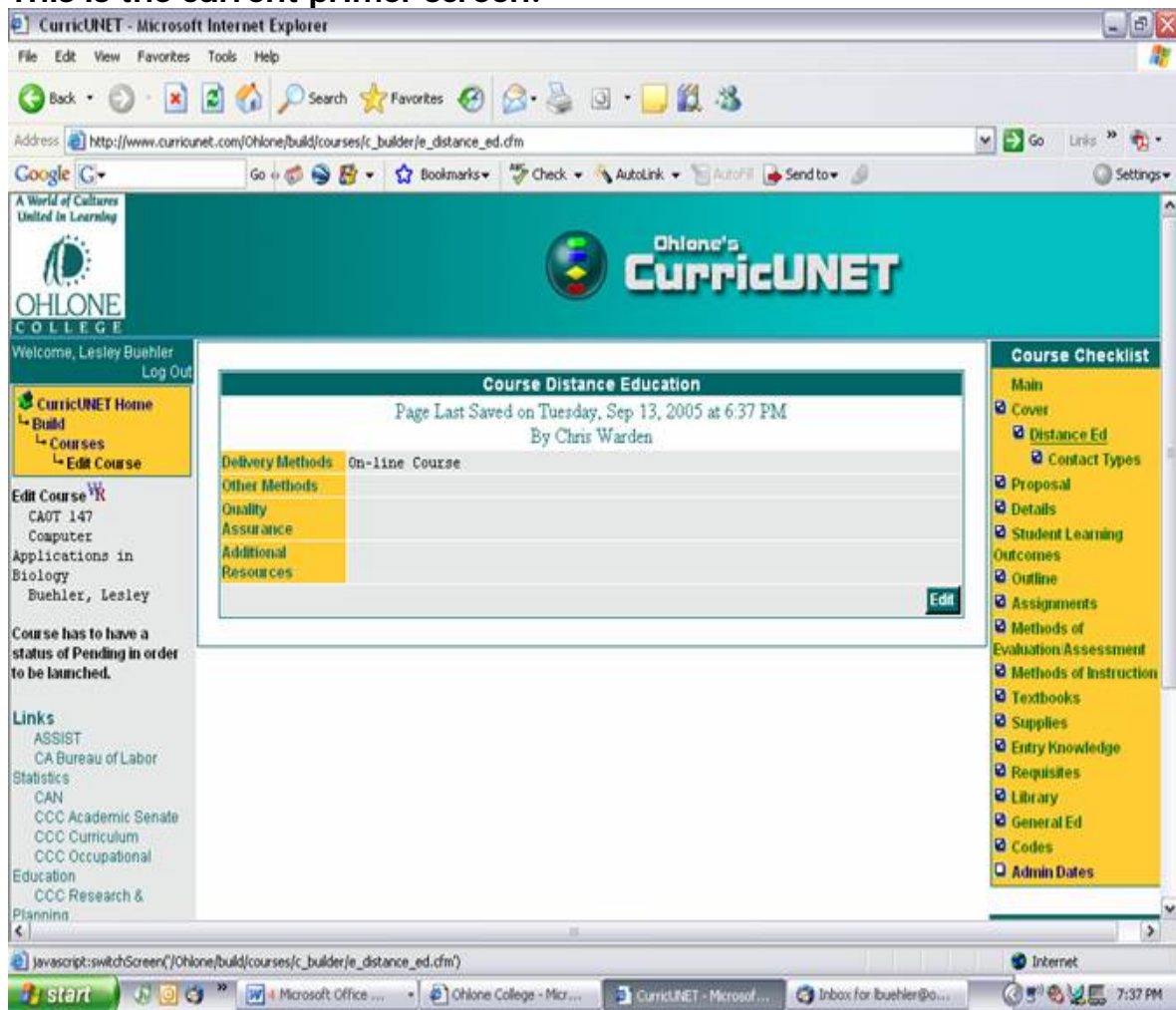

Guidelines to include an area:

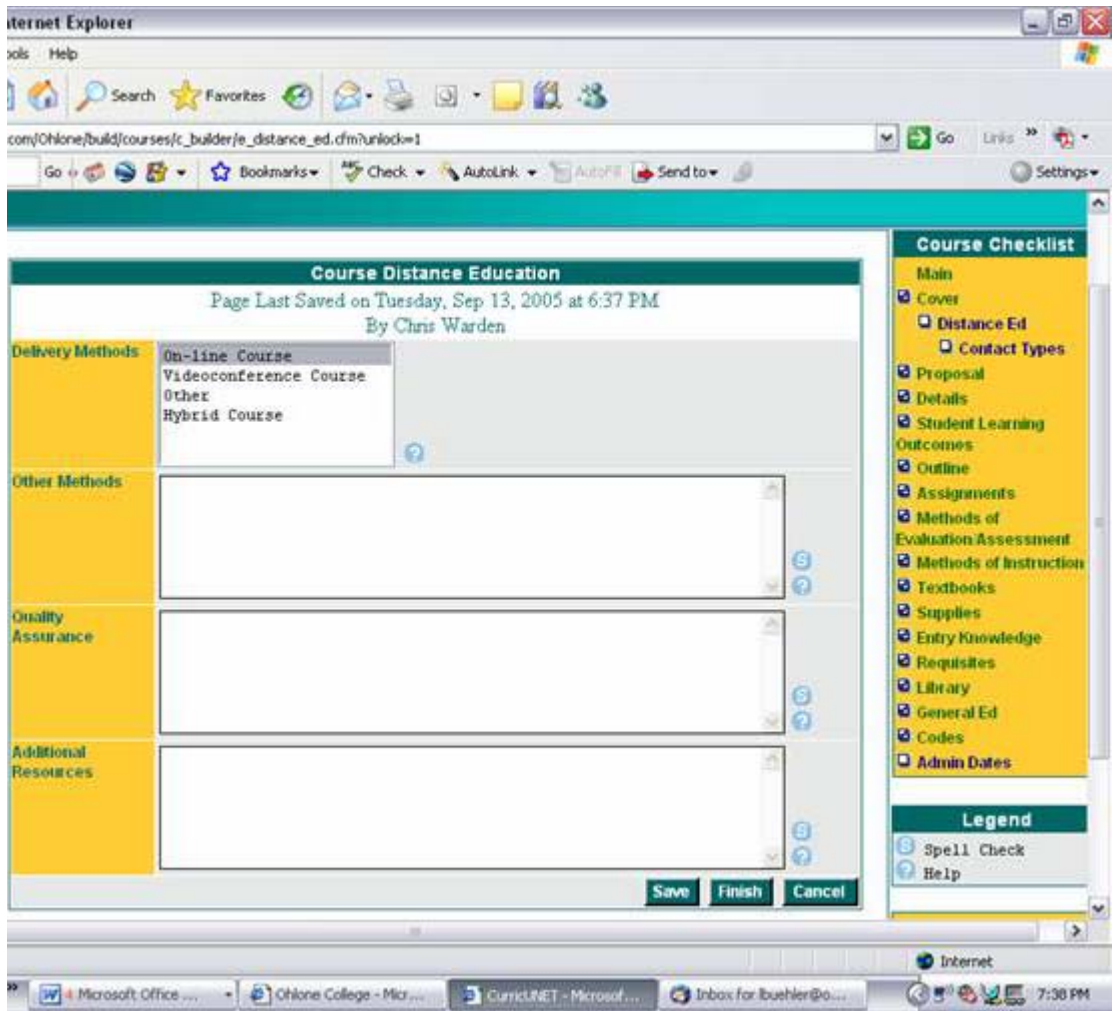
